

## BRANDING WITH TYPE STANDARD END USER LICENCE AGREEMENT (EULA). LICENSE TYPE: BRANDING WITH TYPE

This End User Licence Agreement is made between you ("the Licensee") and Alberto Romanos Hernández ("Branding with Type"). Please read these terms and conditions of this End User Licence Agreement very carefully as this licence contains important information which will govern your use of this software. Any order you submit is subject to these terms and conditions and by using this software and/or submitting an order you irrevocably confirm that you have read, understood and agreed to these licence terms and conditions.

Branding with Type advises you to print out a copy of these licence terms and conditions and keep the copy for your records. Once purchased, this software is non-refundable and these terms and conditions are binding.

### 1. Definitions

"Branding with Type" means Alberto Romanos Hernández, its successors and assignees, its parent and affiliated corporations, its authorized distributors, and any third party which has licensed to Branding with Type any or all of the components of the Font Software supplied to the Licensee.

"Licensee" means the individual, company, corporation, or other organization subject to this End User Licence Agreement due to their access or use of Branding with Type Font Software.

"Font Software" means the software provided by Branding with Type which, when used on an appropriate Device or Devices, generates typeface and typographic designs and ornaments. Font Software shall include all bitmap representations of typeface and typographic designs and ornaments created by or derived from the Font Software. Font Software includes upgrades, updates, related files, permitted copies, permitted conversions, and related documentation.

"Device" means any hardware intended to be used by one single user at a time. It includes, but is not limited to, desktop computers, laptops, hard drives or any similar device.

### 2. Grant of Licence

In consideration of the correct and complete fee paid by you to Branding with Type for this Font Software, the Licensee is hereby granted a non-exclusive, non-transferable (except as expressly permitted) licence to use the Font Software on up to the maximum number of Devices, subject to all of the terms and conditions of the EULA.

This Branding with Type Font Software contains intellectual property information protected by Spanish law, by the copyright and design laws of other nations, and by international treaties. Any copyright, trademark and other rights belong to Branding with Type. This agreement grants you the right to use the Font Software, but you do not gain ownership over it.

You have no right to this Font Software other than as expressly set out in this EULA. You acknowledge that all rights (including without limitation any Intellectual Property Rights) not expressly granted to you under this EULA shall be reserved by Branding with Type.

### 2. Scope of Use

You may make back-up copies of this Font Software as may be necessary for its lawful use. You shall take steps to prevent unauthorised copying and/or use of this Font Software which is not in accordance with the terms of this EULA.

You may embed the Font Software only into an electronic document that does not permit the extraction of the embedded Font Software.

You have no right to embed the Font software, or any part of it, on any media other than the specified usage in this EULA. You have no right to convert the Font Software to any format other than those provided by Branding with Type.

You have no right (and shall not permit any third party) to copy, adapt, reverse engineer, decompile, disassemble, modify, adapt or make error corrections to this Font Software, in whole or in part.

### 3. Authorised Use

#### Desktop:

You shall ensure that this Font Software is only used and utilised on the number and type of Devices for which you have been authorised. By means of an example, if you have obtained and paid for a licence for five (5) Devices then you shall ensure that a maximum of five (5) copies of this Font Software are available for use and exploitation on separate Devices. If you use a networked system for your devices then only a maximum of five (5) Devices shall be capable of using this Font Software via the networked system and that such devices shall be operated and utilised by a maximum of five (5) individuals. You shall ensure that any such network systems are configured in such a manner that only the number and type of users in respect of which you have received authorisation to use this Font Software from Branding with Type may and are permitted to access this Font Software in accordance with this EULA.

#### Webfont:

You have the right to embed the Font Software on website domains owned by the Licensee regardless of the number of visitors, using the @font-face selector in CSS files. Only the original webfont files supplied by Branding with Type can be used as webfonts (.eot, .woff and .woff2). This EULA allows only for self-hosting. The use of third party font hosting services is strictly prohibited.

#### Mobile app & Epub:

You have the right to embed the Font Software on mobile apps and Epub documents owned by the Licensee, providing that the extraction of the embedded Font Software is not permitted. Only the .otf files supplied by Branding with Type can be used.

#### Broadcast:

You have the right to use the Font Software for the production of audiovisual communications, providing that you don't exceed the maximum number of Devices authorised by this EULA.

### 4. Third Parties Use

You may lend a copy of this Font Software to any freelance, collaborator, printer or service bureau which you hire for output, provided that they do not use the Font Software for any purpose other than outputting your work (and they are contained among the number of Devices licensed). It's your sole responsibility to ensure any third party don't incur on any breach of this license agreement.

The Licensee may not sell, rent, lease, sublicense, give, lend, or further distribute the Font Software, or any copy thereof, except as expressly provided herein.

### 5. Termination

This EULA shall automatically terminate upon failure by the Licensee (or any authorized person or member of the Licensee's immediate household to whom the Licensee has given permission to use the Font Software) to comply with its terms. The termination of the EULA shall not preclude Branding with Type from suing the Licensee for damages of any breach of the EULA. The EULA may only be modified in writing signed by Branding with Type.

### 6. Warranty

Branding with Type makes no warranty, express or implied, that this Font Software is suitable for any specific purpose. Branding with Type will provide the Licensee with basic technical support on the correct installation and exploitation of the Font Software in common software packages and operating systems upon request for a period of thirty (30) days from the commencement of this licence agreement. Once the Font Software has been downloaded online, the software cannot be returned.
